

Caution/ Disclaimer Notice to Public against Tower Frauds

The general public is hereby informed that M/s Sistema Shyam TeleServices Limited a company incorporated under the Companies Act, 1956 having its corporate office at 334, Udyog Vihar, Phase IV Gurgaon – 122001, (hereinafter referred to as “MTS”), is engaged, inter alia, in providing cellular mobile granted by the Government of India. The general public is hereby further informed that MTS acquires / takes sites on lease/ leave & license basis for the erection of its telecom towers, either itself or through its authorized agents/ vendors..

Public is cautioned that certain unscrupulous persons who neither belong to nor have any connection with MTS are misleading the innocent public by giving false promises to lure them to part with money on the pretext of taking their land/roofs on rent for installing towers. The public at large is hereby further cautioned that MTS executes all agreements / arrangements relating to the sites in the name of Sistema Shyam TeleServices Limited at its own designated office premises. MTS has not given any authority to any third party to execute any agreement/ memorandum of understanding for acquiring any site for the said purposes on its behalf .Any person executing any lease/ leave & license agreements / arrangements for his / her property with anybody in the name of MTS at any other place except the MTS designated offices, shall be responsible, for his/her own acts and for any loss, cost or expenses occurred to him/her and MTS will not be responsible/ liable in any manner for any such dealings.

This notice is being put on the web by MTS management to caution the public at large to beware of any fraudulent transaction(s) and to disclaim any liability or responsibility in this regard.

Public Notice - Recruitment Fraud

It has come to our notice that in the recent past, some individuals/ recruitment agencies (“**Unscrupulous Elements**”) have tried to mislead the public by fictitiously claiming to be employees of Sistema Shyam TeleServices Limited (“**SSTL**”) or posing as authorized recruitment agencies of SSTL.

It has also come to our attention that these Unscrupulous Elements send fake e-mails to the potential job seekers luring them with job offers and appointment letters using fake offer letters, SSTL’s name, logo and address in fake stationary.

Kindly note that SSTL follows a formal recruitment process through its own HR department and does not outsource the final selection of prospective employees to any individuals or agencies. Further, SSTL does not send any e-mail correspondence relating to employment from free web based email accounts such as Gmail, Ymail, Hotmail, Rediffmail and so on.

Please be advised that any potential job-seeker willingly corresponding with such individuals and recruitment agencies in any manner whether by e-mails or otherwise will be doing so at their own risks and consequences. SSTL strongly recommends that the potential job-seekers should not respond to such solicitations.

Kindly note that SSTL will not accept any liability for any loss or damage that may be suffered or incurred directly or indirectly through correspondence with fraudulent individuals or

recruitment agencies and that such communication should not be treated as an offer or representation from SSTL.
